- Please ensure you sign and date the form, so we are able to store this information on our database.
- The standard school menu will be adapted based on the information provided on the returned form.
- Our Allergies and Intolerances process does not cater for likes and dislikes.
- For safety, a pupil with an allergy and/or intolerance will not be provided with a school meal until the parent/guardian have received confirmation and the school kitchen have received the relevant menu information.
